CONSTITUTION OF ANTI-RAGGING COMMITTEE AND ANTI-RAGGING SQUAD

1. Preamble

In compliance with the regulations issued by the All India Council for Technical Education (AICTE) and the University Grants Commission (UGC) under the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, Sri Rachapudy Nagabhusanam Degree & PG College, Badvel hereby constitutes the Anti-Ragging Committee and Anti-Ragging Squad to prevent and prohibit ragging in the institution.

The institution adopts a Zero Tolerance Policy towards ragging in any form.

2. Objectives

The Anti-Ragging Committee and Squad shall:

1. Prevent ragging in any form within the campus and hostel premises.
2. Create awareness among students regarding the ill-effects and legal consequences of ragging.
3. Ensure a safe and supportive environment for freshers and all students.
4. Monitor and maintain discipline in the institution.
5. Take immediate action on complaints related to ragging.

3. Definition of Ragging

Ragging includes any conduct by any student or group of students that:

- Causes physical or psychological harm, fear, shame, or embarrassment.
- Teases, abuses, threatens, or intimidates a fresher or junior student.
- Involves verbal, written, or online harassment.
- Forces students to perform acts against their will.

Ragging is a punishable offense under law.

4. Composition of Anti-Ragging Committee

The Anti-Ragging Committee shall consist of:

The Committee shall meet at least once in a semester and review the anti-ragging measures.

5. Functions of Anti-Ragging Committee

- Formulate and review anti-ragging policies.
- Monitor implementation of preventive measures.
- Conduct awareness programs and orientation sessions.
- Review reports submitted by the Anti-Ragging Squad.
- Recommend disciplinary action in proven cases.

6. Composition of Anti-Ragging Squad

The Anti-Ragging Squad shall consist of:

The Squad shall work under the supervision of the Anti-Ragging Committee.

7. Functions of Anti-Ragging Squad

- Conduct surprise inspections in classrooms, campus areas, and hostels.
- Maintain vigil over potential ragging-prone areas.
- Receive and investigate complaints of ragging.
- Submit reports to the Anti-Ragging Committee for further action.

8. Preventive Measures

The institution shall:

- Obtain Anti-Ragging Undertakings from students and parents as mandated.
- Display anti-ragging posters and helpline numbers prominently.
- Publicize strict disciplinary actions for ragging.
- Conduct orientation programs for freshers and seniors.

9. Punishments for Ragging

Depending on the severity, punishments may include:


- Suspension from attending classes
- Withholding scholarships/fellowships
- Debarring from examinations
- Suspension/expulsion from the institution
- Filing of FIR with police authorities

10. Implementation

This Constitution shall come into force with immediate effect and shall remain valid unless amended as per AICTE/UGC regulations.



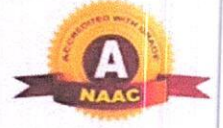
